Collection of your Personal Information and how we use it:

About this statement

This statement will tell you about how we collect and use information about you. We will not store or process your personal information outside of Ireland.

What information do we collect

We may ask you to give us certain information when you use this web site. You will know when we are collecting information which we intend to keep for future use because the web page will contain a link to this statement. The information we collect depends on which services you use. The information may include:

- your name and date of birth
- your postal address;
- your e-mail address;
- your gender;
- your occupation;
- your interests;
- Other information relevant to customer surveys or promotions;
- Your credit card details (for purchases);
- Details of your orders

We also use cookies. A cookie is a small amount of data which is stored on your computer and which is revealed to us when you use this web site. We use cookies only to make it easier to identify you when you visit the website. We do not use cookies to collect additional information about you. You can configure your web browser not to accept cookies, although this may hinder the functionality of our web site.

Who else can use your information

We may pass your information to others:

- We use sub-contractors to deliver your goods and we may pass your name and address to them.
- We will pass your information to others if you indicate that you want to receive marketing material or similar communications from them.
- We may provide other companies, such as advertisers, with statistical information about our customers, but we do not provide them with information which can be used to identify any individual customer.

- We may pass your details to our professional advisers for the purpose of obtaining professional advice.

How will we use your information

We can use your information to customise the website according to what you tell us about your interests. We may send you information about special offers or other items that we think may be of interest to you.
